Dear Neighbours,

Erith Contractors have been appointed by the developer to undertake the enabling phase of redevelopment at 100 Gray's Inn Road, 88 Gray's Inn Road and 127-135 Clerkenwell Road, London. We expect to commence full site set-up from Monday 28th August 2023.

Once the site has been set up and secure, we will welcome our full workforce and the more significant works will then commence. Our scope includes Soft strip of the buildings, demolition, temporary works, basement works, piling and the construction of 2 cores for the 9 levels.

From 14th August - Early on site preparation activities

- Internal setting up of the site offices and welfare facilities within the existing building at 88 Grays Inn Road will commence from Monday 14th August.
- Hoarding to segregate and protect the courtyard area will commence on 21st August.
- Discussions with Camden Council, third parties and other relevant departments regarding various permissions and licenses required prior to beginning works.
- Condition surveys of the surrounding area.
- Formal submission of the Construction and Environmental Management Plan to Camden.

What's next?

Works following site establishment will include:

- Installation of CCTV for site security.
- Installation of tree protection.
- CCTV and track & trace surveys of existing services to enable Isolations & disconnections of services.
- Early structural surveys and enabling works within and around the building in preparation for the main works.
- Site investigations and Floor Load-Testing.
- Installation of protection to UKPN substation & vents.
- Enabling roof removal for plant lift.
- Form vertical transition routes & internal loading point.
- Install scaffold to internal elevations.
- Install scaffold gantries to the Grays Inn Road and Clerkenwell Road elevations.
- Install scaffold above the installed Gantries.

Logistics

The main site vehicle access will be located on Grays inn Road.

All site vehicle movements will be controlled using our team of experienced Traffic Marshals.
