The crane was utilised to lift demolition plant to the roof level.






The front elevation scaffold, pedestrian gantries and hoarding erections are complete, inclusive of protective sheeting installations.

The oversail scaffolds were also completed in the period, readiness of the demolition activities.






The demolition activities have commenced and are progressing as planned.

Demolition of the 100 Gray's Inn road building have reached level 5, and the 127 Clerkenwell Road building has reached level 4.





Demolition arisings continue to be removed via our vertical transit route from the demolition floor, to our ground floor courtyard area.

From here, the wastes are loaded into skips using our excavator, and removed from site via Gray's Inn Road.





Works to the UK Power Networks single substation are now complete.

UK Power Networks are due to commence fitout works and commissioning of the substation in the next period.


ERITH – Community and Social Value





Clerkenwell Road Pit Lane



We are currently in discussion with Camden's highways department & TFL to agree the implementation of our proposed Clerkenwell Road pit lane.

The operational hours of the pit lane are proposed to be 09:30 to 18:00 Mon-Fri, and 09:00 to 14:00 on Saturdays.


The status of these discussions are agreeing the particulars of the pit lane and coordinating these works with the planned/upcoming highways upgrades in the local area.

The following slides detail our current proposals for the pit lane, where we have provided a plan for phase 1 (pre-highways upgrades), and a plan for phase 2 (posthighways upgrades).

Phase 1 of our pit lane is due to be implemented from June/July 2024.
