Dear Neighbours,

Welcome to the eighth edition of our newsletter update which we continue to produce and issue regularly to ensure you are kept informed and updated about the works that are being undertaken at the Grays Inn Road Development as they progress. In addition, periodic and timely information notices will be issued when necessary.

Recent, completed and ongoing activities

- All scaffold erections are now complete. Monarflex has been installed to all elevations of scaffold, encapsulating the existing building.
- Demolition of the 100 Gray's Inn Road building is now complete down to LO1.
- Demolition of the 127 Clerkenwell Road building is now complete down to L01.
- The perimeter protective scaffold is being progressively removed with the demolition activities.
- Weather protection installations and the engineered party wall wind protection screens are being installed progressively with the demolition activities.
- Phase 1 propping has been installed at basement level (RMD propping to perimeter), which has been installed to

enable the removal of the ground floor slab.

- Hoarding erection within quiet gardens is complete.
- Discussion with London borough of Camden around the proposed pit lane in Clerkenwell Road is ongoing following consultation.
- Disconnection of the Clerkenwell Road substation by UKPN is now complete. UKPN will be attending site on Saturday 22nd of June to remove their redundant kit from the room.

What's next? Works and activities in the next 2 months

- Completion of the superstructure demolition (down to GF slab).
- Commencement of the substructure demolition (ground floor & basement slabs). These works are forecast to complete by August this year, which will conclude the main demolition activities.
- CFA Piling works to the south-east corner of site are due to commence in July.
- The substructure construction activities are also due to commence in July.
- Tower crane erection due to take place in August. An information notice will be circulated closer the time with further details.

Logistics

The main site vehicular access and egress continues to be located on Grays Inn Road. We will soon also have vehicles entering site via our Clerkenwell Road entrance, with this being used for the substructure waste removals.

All site vehicle movements will continue to be controlled by our team of experienced Traffic Marshals.
